

# TERMS AND CONDITIONS OF ENROLMENT

## (APPLIES TO ALL STUDENTS)



### GENERAL

- Students 16 years and older must be fully vaccinated. If at any time Covid-19 situations arise, all students will return to online classes.
- Due to the co-working nature of DanceMajic, students under the age of 18 years are not to leave the studio they are working in at any time unless under adult supervision. This includes going to the bathroom, moving between studios and break time.
- Students will be supervised during break times by a staff member of DanceMajic.
- DanceMajic encourages the supportive environment between both staff and students, where students feel safe to learn, create and express themselves.
- It is important to advise DanceMajic of any changes to your enrolment or contact details throughout the year.
- As the end of year concert is an important event for all students, we expect that by the commencement of term 2, a commitment is made to stay on until the end of the year. This prevents the student's and DanceMajic's hard work going to waste. All concert costumes are ordered approximately in term 2.
- Concert tickets, DVD, concert costumes and troupe costumes fee are non-refundable.

### UNIFORM

Students are required to wear the correct full uniform as per the class they are taking. Uniforms are compulsory in 2023. (Students expected to have uniform 4 weeks into the term).

Students not in uniform may be required to sit and watch the class.

Uniforms ordered through DanceMajic will not be distributed until full payment has been made.

Whilst wearing licensed DanceMajic uniform, students are a representative of the studio and should behave accordingly as not to present the studio in a negative light.

### FEES AND PAYMENT

- A **non-refundable registration fee** of \$10 is payable upon enrolment for all students to secure their place (\$15 to register a family).
- Full term class fee payments are to be paid in full by week 3 of the term. Alternatively, the year balance can be paid in monthly or fortnightly instalments. Class fees can be paid by direct bank transfer or cash. Please see below for Bank Transfer details. For further enquiries relating to fees and or payments, please speak with Derralie Coonan (Principal).
- Please ensure all payments made by Bank Transfer have a clear reference to the reason for payment made (e.g. Term Fee Invoice #, Payment Invoice #, Exam Fee #).
- Fees that are late will incur a 10% fee for full term payments.
- If fees are more than 3 weeks overdue, the child will be required to sit and watch the class without participation until the owing balance is paid.
- Two weeks' notice in writing is required for any child who decides to leave the studio. No refund will be given for classes not attended or for any remaining classes in the instance a student leaves prior to the end of term when term payments are made.

## CONCERT

All students will be working throughout the year towards an end of year concert. It is expected that every student attend and participate in the end of year concert. Our concert date is **Sunday November 19th 2023** and full dress rehearsal date is **Monday November 13th 2023** (both to be held at Darebin Arts & Entertainment Centre, Preston).

It is compulsory for every family to order at least 6 tickets to our Annual Showcase. This is required as we would like the students to perform to a full Theatre.

All students require costumes for our end of year concert. Parents must be prepared to finance this. Costume money can be paid into the costume bank. At the end of term 1 all students require at least \$60 in their costume bank. Each term requires a further \$60 and so on. DanceMajic makes every effort to minimise this cost.

Costumes vary in price, but an estimate is:

<b>Sub - Juniors:</b>	\$40 per costume	<b>Intermediates:</b>	\$60 per costume
<b>Juniors:</b>	\$50 per costume	<b>Seniors:</b>	\$70 per costume

Concert costume fees are non-refundable. A rehearsal fee of \$20 per child is required in term 4 to cover costs involved with concert rehearsals. There will also be a charge for the teachers presents for our end of year concert. This will be debited form the costume accounts.

## BULLYING

**No bullying of any kind will be tolerated by DanceMajic.** This includes verbal, physical, and emotional torment. Any person to be found guilty of bullying will be at risk of temporary suspension or permanent expulsion. Should there be instances of bullying exceeds DanceMajic's authority, the relative law enforcements will be contacted.

## STUDIO REPRESENTATION

- All choreography remains the property of DanceMajic.
- As a soloist, to represent DanceMajic at competitions and performances, students must be enrolled in general classes at DanceMajic.
- Students who are performing under DanceMajic are representing the studio. Both students and parents should behave accordingly. Anyone found to be representing the studio in a negative light will face repercussions.

## SOCIAL MEDIA

- By enrolling in DanceMajic, you consent to allowing photography and videography on DanceMajic's social media platforms. Any requests against this must be made in writing to the director or at the time of enrolment.
- By allowing media consent of your child/ren to DanceMajic you allow imagery and videography to be used for promotional purposes from the time consent is given.

- All social media use will be appropriate, safe and in context. Pages are monitored heavily, and foul behaviour will not be tolerated.
- Students with their own social media accounts are representing DanceMajic and should behave in such manner. DanceMajic strongly encourages parental guidance and monitoring of behaviours of both their child and other people on social media.
